


TBM at face of gutter on curb return of Jennifer Court and Domenico Drive for Lot 8, Elevation 433.95. Datum used in NGVD 1947 Northwest Readjustment which when common monuments are compared is equal to datum used on FIRM. Recommend finish floor at Elev. 435.00.



The diagrams above illustrate the points at which the elevations should be measured in A Zones and V Zones. Elevations for all A Zones should be measured at the top of the reference level floor. Elevations for all V Zones should be measured at the bottom of the lowest horizontal structural member.
