#### **General Information**

Welcome to the 2022 City of Roseburg Election Information pamphlet. This pamphlet is meant to provide voters with valuable information about candidates and measures that will appear on the ballot in Roseburg, Oregon. Printed copies of the City of Roseburg Election Information pamphlet are available at the Roseburg City Hall Lobby finance window, 900 SE Douglas Ave., Roseburg Public Library, 1409 NE Diamond Lake Blvd., and Roseburg Public Safety Center, 700 SE Douglas Ave.

### **Candidates**

Candidates for the Roseburg Mayor and City Council, Roseburg Public Schools Board, Roseburg Urban Sanitary Authority (RUSA) Board, Umpqua Community College (UCC) Board, and Douglas Education Service District (ESD) Board may submit information for the City of Roseburg Election Information pamphlet. No other candidates will be included in the pamphlet.

Candidate statements are printed as submitted. The City does not correct punctuation, grammar, syntax errors or inaccurate information. The City may, but is not required, to correct spelling errors.

### **Measures**

Measures, as well as arguments for or against measures, for the City of Roseburg, Roseburg Public Schools, Roseburg Urban Sanitary Authority (RUSA), Umpqua Community College (UCC), and Douglas Education Service District (ESD) may be submitted for inclusion in the City of Roseburg Election Information pamphlet. No other measures will be included in the pamphlet.

Measures are printed as submitted. The City does not correct punctuation, grammar, syntax errors or inaccurate information. The City may, but is not required to, correct spelling errors.

### Registering to Vote

You may register to vote online at <u>State of Oregon: Voting-Oregon Online Voter Registration</u> or you can get a voter registration card at Douglas County Elections, the City Recorder's Office, the DMV, or other locations around the city. Your voter registration card must be postmarked no later than 21 days before the election at which you intend to vote. In order to register to vote in Oregon, you must be at least 16 years old, a resident of Oregon and a citizen of the United States. If you are 16 years old, you will not receive a ballot until an election occurs on or after your 18th birthday. For the November 8, 2022 General Election, your completed voter registration card must be either:

- Postmarked by Tuesday, October 18, 2022.
- Delivered to a county elections office by Tuesday, October 18, 2022.
- Delivered to any voter registration agency (e.g. DMV) by Tuesday, October 18, 2022.

If you register to vote online (with a valid Oregon Drivers' License or State issued ID card), your registration must be submitted by 11:59 p.m. on Tuesday, October 18, 2022. #### **Voter Information**

In Oregon, elections are all vote-by-mail. Registered voters are mailed a ballot approximately two weeks before an election. To vote, follow the instructions on the official ballot. Your return identification envelope must include your signature. Return your ballot by mail to any official ballot drop site location or by mail to Douglas County Elections, 1036 SE Douglas Avenue, Room CH124, Roseburg, OR 97470. Ballots must be postmarked or received at an official drop site location by 8:00 p.m. on Election Day, November 8, 2022. A list of drop site locations is included with your ballot material. Psilocybin-Related Businesses

### **CAPTION:**

CONCERNING PSILOCYBIN-RELATED BUSINESSES WITHIN THE CITY OF ROSEBURG, OREGON

### QUESTION:

Shall the City of Roseburg allow psilocybin-related businesses in Roseburg?

### SUMMARY:

State law allows for the manufacture, distribution and possession of psilocybin and psilocin. State law provides that a city council can refer the question of prohibiting/allowing psilocybin to the voters. If adopted by the voters, this measure would allow the establishment of psilocybin product manufactures and/or psilocybin service center operators within the City of Roseburg. If not adopted by the voters, the establishment of psilocybin product manufactures and/or psilocybin service center operators will be prohibited within the City of Roseburg.

Measure 10-204
Psilocybin-Related Businesses
Explanatory Statement


Approval of this measure would allow the establishment and operation of certain psilocybin product manufacturers and service center operators licensed by the Oregon Health Authority. Psilocybin mushrooms are wild or cultivated mushrooms that contain psilocybin, a naturally occurring psychoactive and hallucinogenic compound.

Measure 109, approved by Oregon voters in November 2020, provides that the Oregon Health Authority shall license and regulate the manufacturing, transportation, delivery, sale and purchase of psilocybin products and the provision of psilocybin services.

Under Measure 109, cities may refer the question to voters on local ballots to allow or prohibit psilocybin-product manufacturers and/or psilocybin service centers within their jurisdictions. The City Council of Roseburg has adopted a resolution referring this measure concerning psilocybin manufacture and service center operations within the City of Roseburg to the voters.

If adopted, this measure would allow licensed psilocybin product manufacturers and service center operators to operate within the City. If not adopted, this measure would prohibit licensed psilocybin product manufacturers and service center operators from operating within the City.

The authority to impose a tax or fee on the manufacturing or sale of psilocybin products, or the provision of psilocybin services in Oregon is vested solely in the Legislative Assembly. Additionally, Measure 109 prohibits a city from adopting or enacting an ordinance imposing a tax or fee on psilocybin manufacturing or the provision of psilocybin services. Consequently, approval of this measure should not have any revenue impacts on the City.
