CITY OF ROSEBURG ECONOMIC DEVELOPMENT COMMISSION MINUTES January 12, 2021

CALL TO ORDER

Chair Brian Prawitz called the Zoom meeting of the Economic Development Commission to order at 3:30 p.m.

ROLL CALL

APPROVAL OF MINUTES

Commissioner Zegers moved to approve the minutes of the October 13, 2020 meeting as submitted. The motion was seconded by Commissioner Beach and approved with the following votes: Chair Prawitz, Commissioners Baglien, Beach and Zegers voted yes. No one voted no.

DISCUSSION ITEMS

Coronavirus Relief Fund Update

Ms. Messenger shared a brief report on the City's distribution of Coronavirus Relief Funds (CRF).

November 9, 2020, City Council authorized an interfund loan from the Assessment Improvement Fund to the Grant Fund to provide the cash flow needed to implement the CRF grant program.

In order to receive funding, the City entered into an agreement with the State of Oregon. The agreement outlined certain conditions that had to be met by the grantee (City) and any sub-grantees.

The City committed \$518,148 in grant funds to community partners. Per state and federal requirements, all of the funding was spent prior to December 30, 2020.

The City provided support to the following:

Local Businesses:

- CCD Business Development Corporation \$220,000
- Roseburg Area Chamber of Commerce \$34,100

Local Citizens:

- United Community Acton Network \$75,000
- Douglas Education Service District \$30,000

Non-Profits – The City entered into CRF Funding agreements.

- Salvation Army \$15,000
- Peace at Home \$15,000
- St. Vincent de Paul \$40,000
- YMCA of Douglas County \$10,000
- Chadwick Clubhouse \$5,000
- Roseburg Rescue Mission \$20,000
- Roseburg Senior Center \$5,000
- Meals on Wheels \$2,000 (funds will be released once required insurance is received)
- Thriving Waters/Umpqua Valley Farm to School \$6,731
- Safe Haven Maternity Home \$8,000
- Connecting Point (HIV Alliance) \$2,619
- Unfortunately, the Dream Center was unable to submit an application due to an operation closure due to staff quarantine.

Tourism Recovery

Anvil Northwest - \$29,428

Commissioner Beach commended the City for the distribution of the awarded funds.

Theresa Haga shared the following information regarding the State of Oregon COVID-19 Emergency Business Assistance Grant Program, Impact of Round 1-4.

- City of Roseburg contributed \$50,000 and an additional \$150,000. CCD was able
 to leverage the additional CARES Act funding received by the City of Roseburg and
 award additional grants.
- CCD launched Round 4 Grant Program on October 1, 2020. Round 4 was completely allocated within 14 business days. Approximately \$1.6 million in requests received prior to closing the Round 4 portal. All funds received by the City of Roseburg were awarded and deployed to businesses located within the city limits.
- 49 Businesses received grants from City of Roseburg Funds (\$200,000 + \$20,000 Round 1)
- 371 Businesses received grants from Round 4 State of Oregon Fund (\$1,774,000)
- \$2,594,000 Grant Funds deployed in approximately 4 months
- 648 Businesses received grants (309 Coos County, 52 Curry County & 287 Douglas County)
- Coos County received \$1,065,711 (110 Grants Awarded)
 599 Jobs associated with the businesses who received grants
- Curry County Received \$701,109 (50 Grants Awarded)
 405 Jobs associated with the businesses who received grants
- Douglas County received \$1,473,569 (103 Grants Awarded)
 - 931 Jobs associated with the businesses who received grants

Ms. Messenger stated we are fortunate to have CCD as a partner. Additional funding was received because CCD was on the ball and delivered the grant funding quickly and efficiently.

Ms. Haga stated it was a team effort and she is proud of the amount of money that came to our region and were able to serve.

Chair Prawitz thanked everyone involved.

INFORMATIONAL

Experience Roseburg/Anvil Northwest Report

Mr. Campman provided a power point presentation on the Quarterly Review and highlighted the following.

- Content Creation They are learning to navigate the current COVID situation as they

- Adding Ecommerce Experienceroseburg.com will soon have an on-line store, offering all branded swag.

- Changes to Guide After the release of the spring issue of UV magazine, they will
 no longer contract with AHM Brand. Experience Roseburg will create the ER visitor
 guide in-house to save approximately \$50,000, which will allow them to reach more
 individuals.
- Adding a YouTube channel called Between Two Rivers which began shooting in January.

Ms. Raines provided an update on the following:

- Eugene Airport Digital Displays in Baggage Claim decreased nearly 53% from 2019 due to a decrease in passengers flying during COVID pandemic; however, flights will increase again and the displays will be beneficial.
- OTIS Listings: TravelOregon.com Digital Increased Roseburg Listings from 130 to 154. Categories: 22 Restaurants, 2 Coffee & Tea businesses
- Festival of Lights was a full page add in the UV Magazine Fall/Winter 2020 issue
- Northwest Travel and Life is the most popular and has the greatest exposure
- SeeSource Campaign results

Ms. Rifenbark provided an update on the following: Social media numbers on Facebook, Instagram Engagement, Social Activity, Social Engagement, Top Channel Posts, Top Landscape Posts, and Website Referrals.

Mr. Campman provided the total expenditures for October and November and stated the financials for December's expenses wouldn't be available for a couple weeks; however, he will forward the information once available. He showed a video for a Pilot Footage, and reported having a good response by viewers.

Partnership Report

Mr. Patterson provided a brief overview of the Partnership Report stating they are working on infrastructure, three new businesses are moving into Douglas County, GrowthTalks will resume next month, and a meeting is scheduled with Blue Zones regarding the Food Hub project to discuss how to get local products into the hands of locals.

The Partnership will continue to work on workforce development and all the areas needed for support, support the community needs through building childcare resources, industrial park developments, building the City Manger's coalition, and continue to support handing out PPE wherever needed.

Commissioner Beach asked if an equestrian center is planned for the Metz Hill area. Mr. Patterson shared there is interest and if the business plan can be accomplished, it would be great for our area.

Chair Prawitz is encouraged that businesses are still coming to Douglas County. He shared the Festival of Lights sold tickets through Event Bright this year and 4500 etickets were sold. Fifty two percent were Douglas County addresses and half were from outside Douglas County. The organization is exploring how the nutcracker can be resurrected since it is a big attraction.

ISSUE STATEMENT AND SUMMARY

The following is a brief report on the City's distribution of CDBG COVID-19 Small Business and Microenterprise Assistance funding.

BACKGROUND

On August 18, 2020, the City of Roseburg was awarded a \$150,000 Community Development Block Grant (CDBG) through the Oregon Business Development Dept. in order to provide financial relief to small businesses and microenterprises within the City of Roseburg and Douglas County affected by COVID-19. On October 1, 2020, the City of Roseburg officially entered into a contract with the Oregon Business Development Department. Shortly thereafter, an additional contract was developed between the City and the CCD Business Development Corporation, in which CCD acted as the subgrantee for the project assisting in grant administration and allocating money to qualifying businesses in accordance with CDBG program requirements.

With the assistance of CCD, twenty-one businesses received financial assistance throughout the County. Of these twenty-one businesses, nine were located within the City of Roseburg. Grants ranged from between \$5,000 and \$10,000. A wide variety of industry was assisted with funding, including:

- Restaurants
- Health/Fitness
- Recreation
- Retail
- Personal Service
- Hotel/Motel
- Marketing/Sales

In all, \$137,500 were distributed throughout the community. \$12,500 was used by CCD to help cover administrative costs.

CONCLUSION

In addition to the distribution of the CDBG funding above, as reported during our January 12, 2021 meeting, the City has also distributed \$518,148 worth of grant funds to community partners as part of the Coronavirus Relief Fund (CRF). This money was provided to the City as part of the CARES Act. Per state and federal requirements, all of the funding was spent prior to December 30, 2020. Between these two funding programs the City has helped to distribute a little over \$650,000 worth of funding to local citizens, organizations and businesses struggling from the effects of COVID.

Staff is now recommending City Council authorize staff to apply for an additional CDBG COVID-19 Small Business and Microenterprise Assistance grant. If authorized, the City will work jointly with Douglas County to request the maximum grant amount of \$500,000. If awarded the grant, the City will continue to work with the CCD as the subgrantee, assisting in distributing the funding.

ISSUE STATEMENT AND SUMMARY

The purpose of this discussion item is to provide the EDC with an update on the current status of the Tourism Grant Program. Twice a year during the (fall/winter cycle and spring/summer cycle) the City provides grant opportunities for individuals or groups looking to promote local tourism within our area. These grant opportunities are made possible due to a portion of the hotel/motel tax being used for this purpose. In order for grant submittals to be eligible the proposal must align with the statutory requirements outlined for use of the hotel/motel funds. The grant program typically opens at the beginning of November, with grant requests being approved by the EDC during your January meeting and also at the beginning of May with grant request being approved by the EDC during your July meeting.

Due to COVID19, a decrease in the amount of hotel/motel tax collected by the City began to occur. This money is what is used to fund the Tourism Grant Program. As a result, the City chose to suspend the program for 2020.

Ron Harker, Finance Director with the City of Roseburg will speak to us concerning the quarterly remittance the City has received thus far involving the hotel/motel tax and improvements we are now seeing in this funding as we've progressed through the COVID19 pandemic.

Our hope is after evaluating the 3rd quarter of fiscal year 2020/2021 (Jan. – March), if things look positive we will be able to re-open the Tourism Grant Program this summer for those seeking funding to provide tourism related events in late 2021 and early 2022.

Business Oregon is working with a company looking to locate a new technology data center. The sites submitted were the Reedsport Commerce and Technology Campus, 620 Stearns Ln in Sutherlin, and 2320 Buckhorn Rd in Roseburg.

JULY: PROJECT BRAVE

A European client looking for an industrial site to locate a pulp and paper mill. Their source material will come from recycled paper. The Reedsport Commerce and Technology Campus was submitted.

APRIL 2021: PROJECT ICARUS

Business Oregon is working with a company to evaluate states and regions for a large scale defense-related design and manufacturing facility. Roseburg Airport was submitted.

PROJECT SUMMARY

Workforce Housing

This has been delayed due to COVID: We have been working with Kate Jackson from the Governor's Regional Solutions Team on developing a new sanitation district to support a new area of home development. This area could also have water supplied by a close city that has already offered this. We are also working with another city management team on other possible home building areas. Based on UEDP's housing subcommittee last year, the major obstacle in building lower cost housing for our workforce is land cost, so the idea is to develop lower cost land.

Childcare

The Child Care Coalition continues to meet along with Business Champions for Success. Staffing continues to be the biggest challenge with childcare providers.






