# CITY OF ROSEBURG PARKS AND RECREATION COMMISSION MAY 5, 2021

#### MINUTES

<u>CALL TO ORDER:</u> The meeting of the City of Roseburg Parks and Recreation Commission was called to order at 8:27 a.m. Wednesday, May 5, 2021, electronically via Zoom in Roseburg Oregon.

<u>APPROVAL OF MINUTES:</u> Commissioner Diana moved to approve the minutes of the April 7, 2021 Parks and Recreation Commission meeting. Motion was seconded by Commissioner Grubbs and approved with the following vote: Chair Eggers, Commissioners Finlay, Wales, Bailey, La Verne, Grubbs and Mogavero voted yes. No one voted no.

#### **DISCUSSION ITEMS:**

Recreational Trails Program Grant Application: Ammerman informed the City would like to apply for the Recreational Trails Grant for a project that will include the creation of a small but attractive family friendly hiking, trail running, and mountain biking destination at Sunshine Park. Perkins stated that staff had previously applied for this grant in 2020 but was unsuccessful. Ammerman said Sunshine Park is approximately 93 acres of land, about 50 of which is currently undeveloped. Ammerman informed the program changed some this year, the maximum grant award will only be \$150,000. Last year we applied for \$184,574.21. Staff anticipates the bulk of the difference will be made up with volunteer labor. The preliminary cost for the entire project is \$230,717.81 with a minimum 20% match coming from a combination of volunteer labor and Bike Trail Fund. Commissioner Wales questioned what the status was of the property line issue on the east end. Ammerman replied that the boundary line adjustment had just been finished. Commissioner Grubbs inquired if the parking area would be expanded. Ammerman said there isn't really any space for additional parking.

**MOTION:** Commissioner Grubbs moved to recommend to the City Council the adoption of the Resolution in support of the grant application seeking RTP funding. Motion was seconded by Commissioner Bailey and approved with the following vote: Chair Eggers, Commissioners Finlay, Wales, Bailey, La Verne, Grubbs and Mogavero voted yes. No one voted no.

### **AUDIENCE PARTICIPATION:** None

<u>INFORMATIONAL:</u> Zenya Ledermann the Community Garden coordinator for Blue Zones Project and UCVEG. Ledermann gave brief update on the 3 community gardens in Roseburg. She also informed about upcoming Garden Workshops they will be hosting.

Messenger informed Beulah Park renovation wasn't done yet but it is coming along and looks a lot different than it did couple months ago.

Maintenance report for March/April was provided in the agenda packet.

<u>BUSINESS FROM THE COMMISSION:</u> Commissioner Wales informed the Swifts are migrating, she also gave kudos for the Osprey sign and Butterfly Garden signs.

### **ISSUE STATEMENT AND SUMMARY**

The U.S. Economic Development Administration (EDA) has developed a competitive grant program to help communities that have been hardest hit by challenges facing the travel, tourism and outdoor recreation sectors to invest in infrastructure, workforce or other projects to support the recovery of the industry and economic resilience of the community in the future. The issue for the Parks Commission is whether to recommend that the City Council authorize the City Manager to submit an EDA grant application.

### **BACKGROUND/ANALYSIS**

Commission Background

- On October 3, 2018, the Commission reviewed conceptual expansion plans brought forth by the Umpqua Valley Tennis Center. The expansion plans included reconstructing the outdoor tennis courts, relocating the basketball courts, rehabbing or replacing the Hoffman Tennis Center, and adding two indoor tennis/pickleball courts and an outdoor storage area. The Commission recommended Council give preliminary approval to the conceptual expansion plan, which would allow UVTC an opportunity to begin fundraising efforts.
- At the August 5, 2020 meeting, the Commission heard a request from Umpqua United Soccer Club to make major field improvements at the Fir Grove section of Stewart Park and to update and extend their current user agreement to twenty years to allow them to seek grant funding for the proposed improvements, which included converting one or more fields to synthetic turf.

The EDA has established a competitive grant program funded by \$240 million dollars of American Rescue Plan Act funding. Staff is working with Sequoia Consulting, a professional grant-writing firm, to prepare the grant application. The intent is to seek funds to redevelop portions of Stewart Park into modern regional complex that will facilitate tournaments encouraging tourism, supporting hospitality based local businesses and make Roseburg a more attractive place for professionals and families to call home.

Currently, Stewart Park provides recreational opportunities and sports fields for local youth recreation programs, Roseburg School District teams (baseball, softball, soccer, cross-country,

lacrosse), Umpqua Community College teams, UVC teams, YMCA and Church leagues, and others.

The proposed improvements have not fully been identified, and staff is working with stakeholder groups to refine the initial concepts. The conceptual improvements could include converting existing soccer and softball facilities from grass to turf, adding lighting and spectator facilities (shaded where possible), reconstructing the outdoor tennis facilities with improved lighting, spectator and concession/restroom facilities, constructing new basketball courts and potentially additional sand volleyball and pickle ball courts. Other improvements may include adding electric vehicle charging stations, restroom improvements and/or expansions, backup power at the tennis center so that it may serve as an emergency response site, and additional parks amenities such as benches, shade, etc. Again, the list of improvements is still changing based on input from various user groups and information the consultant has learned from the granting agencies.

### FINANCIAL/RESOURCE ISSUES

The maximum grant application amount is \$10 million; with a minimum 20% match of \$2 million. Preliminary estimates for the project are currently in development. Staff anticipates applying for the maximum amount of \$10 million, which would procure a \$12 million project. Matching funds would come from a combination of sources. Potential sources include the Park Improvement Fund, Stewart Park Trust Fund, Economic Development Fund, Hotel/Motel Tax Fund, General Fund, and fundraising by invested community partners. If successful and the grant is awarded, staff fully expects to recommend the Commission and Council consider a program to sell advertising rights within the new improved facilities to help cover the costs of the match and to establish funding for future replacement costs.

In order to prepare a competitive grant application, staff is working with paid consultants; Sequoia Consulting, i.e. Engineering, and Land & Water.

#### TIMING ISSUES

EDA encourages eligible applicants to submit their applications as soon as possible, and strongly advises eligible applicants to submit complete applications no later than January 31, 2022 so that EDA can review and process the application in time to get a potential award in place prior to deadline imposed by Congress, which is September 30, 2022. Staff's ambitious goal is to submit a grant application by the end of October if possible.

### STAFF RECOMMENDATION

Staff recommends the Commission forward a recommendation to City Council to authorize the City Manager to submit the grant application.

#### SUGGESTED MOTION

I move to recommend the City Council authorize the City Manager to submit the EDA ARPA Travel, Tourism and Outdoor Recreation Grant application for improvements throughout Stewart Park.




# Drawbacks of not having Synthetic Turf/Lights

- Motor skills development.


