CITY OF ROSEBURG PARKS AND RECREATION COMMISSION APRIL 7, 2021

MINUTES

<u>CALL TO ORDER:</u> The meeting of the City of Roseburg Parks and Recreation Commission was called to order at 8:15 a.m. Wednesday, April 7, 2021, electronically via Zoom in Roseburg Oregon.

<u>ROLL CALL: Present:</u> Chair Alison Eggers Commissioners Ryan Finlay, Diana Wales, Kyle Bailey, Marsha La Verne, Bob Grubbs, and Tobiah Mogavero

- Chair Eggers introduced new commission member Tobiah Mogavero. Commissioner Mogavero gave brief update of his past work experience.

<u>APPROVAL OF MINUTES:</u> Commissioner La Verne moved to approve the minutes of the January 6, 2021 Parks and Recreation Commission meeting. Motion was seconded by Commissioner Bailey and approved with the following vote: Chair Eggers, Commissioners Bailey, Wales, La Verne, Finlay, Grubbs and Mogavero voted yes. No one voted no.

DISCUSSION ITEMS:

<u>Beulah Park Improvement – Bid Award Recommendation:</u> Perkins informed City staff has completed the majority of the work that has been done at Beulah Park to date. The next portion of the project is the concrete work. It was bid as two schedules, this was to make sure if the bids were high the majority of the work would be completed. Three bids were received and came in good so will be able to do both schedules. The low bidder was Guido Construction Inc. at \$53,387.50. Perkins informed some of the project will also be funded from the Streetlight/Sidewalk fund.

MOTION: Commissioner Grubbs moved to recommend to the City Council to award Schedules A and B of the Beulah Park Improvement Project to the low bidder, Guido Construction, Inc. for \$53,387.50. Motion was seconded by Commissioner Wales and approved with the following vote: Chair Eggers, Commissioners Bailey, Wales, La Verne, Finlay, Grubbs and Mogavero voted yes. No one voted no.

Five-Year Capital Improvement Plan Update: Perkins informed staff has been updating the City's Five-Year Capital Improvement Plan (CIP). Perkins said the CIP is separated into several different funds, the Parks and Recreation Commission is responsible for advising on the Bike Trail, Park Improvement and Stewart Trust Funds. Perkins said the CIP is a little flexible especially in the parks funds due to grant opportunities. If a grant is received then could move projects up on the list. Perkins briefly went over the funds. He informed we did not receive the grant for the Deer Creek Trail Renovation so it will stay on the list of projects. Commissioner

Mogavero asked what the in-house labor meant, because he knows a lot of private investors that would be interested in helping build the trails without needing grant funding. Perkins said in-house labor is city staff doing the work and that is used as part of the match that is usually required on grants.

MOTION: Commissioner Grubbs moved to recommend to City Council the adoption of the Bike Trail, Parks Improvement, and Stewart Trust Fund components of the 2021-2026 Capital Improvement Plan. Motion was seconded by Commissioner Kyle and approved with the following vote: Chair Eggers, Commissioners Bailey, Wales, La Verne, Finlay, Grubbs and Mogavero voted yes. No one voted no.

BUSINESS FROM THE COMMISSION: Commissioner Wales wanted to give kudos for the many cooperative projects that have happened in various parks. Commissioner Wales also mentioned there would be a project near the butterfly garden at Stewart Park on Saturday, April 10th. Ammerman thanked the many volunteers and community support that help with some of the smaller projects, it is helpful for the City staff.

ISSUE STATEMENT AND SUMMARY

The Oregon Parks and Recreation Department oversees the annual Recreational Trails Program (RTP), which awards grant funding throughout the state. Staff plans to prepare and submit a grant application to the RTP program. The issue for Commission is whether to forward a recommendation to City Council for staff to apply for a Recreational Trails Program Grant.

BACKGROUND/ANALYSIS

Our 2020 attempt at this grant was unsuccessful. RTP is always very competitive, perhaps even more so last year with reduced funding and the even greater need for recreational trails brought on by the global pandemic.

The proposed project will include the creation of a small but attractive family friendly hiking, trail running, and mountain biking destination at Sunshine Park within the City of Roseburg. Sunshine Park consists of approximately 93 acres of land, about 50 of which is currently undeveloped. The proposal consists of three different trail types providing something for everyone. An extension of the existing Universal Access trail will provide a trail experience that complies with the ADA, capable of handling wheelchair use, minimum 5' tread widths, and average overall grades of 5% or less. The addition of Cross Country trails will provide a more classic trail experience. And finally, Flow Style Contour trails will provide a more bike and trail running optimized experience which consists of frequent grade reversals, in sloped turns, faster speeds, and slightly steeper overall trail grades.

A concept map is included to identify the location and scope of the potential project.

FINANCIAL/RESOURCE ISSUES

New to the RTP program this year is a maximum grant award of \$150,000. Last year we applied for \$184,574.21. Staff anticipates the bulk of the difference will be made up with volunteer labor as local trail groups have already committed to supporting the project. Preliminary cost estimate for this project is \$230,717.81 with a minimum 20% match of \$46,143.56 coming from a combination of volunteer labor and the Bike Trail Fund.

TIMING ISSUES

The application must be submitted by June 15, 2021. Staff intends to forward the Commission's recommendation to the May 24th Council meeting.

STAFF RECOMMENDATION

Staff recommends the Commission forward a recommendation to City Council to adopt the attached Resolution supporting the grant application.

SUGGESTED MOTION

I move to recommend to City Council the adoption of the Resolution in support of the grant application seeking RTP funding.

IT IS HEREBY RESOLVED BY THE CITY COUNCIL OF THE CITY OF ROSEBURG, that:


<u>Section 1.</u> Authorization is granted to apply for a Recreational Trails Program Grant for the development of a trail system at Sunshine Park.
