

IF YOU ARE THE VICTIM OF DOMESTIC VIOLENCE OR ABUSE

You can ask the police to take a report so the District Attorney could file a criminal complaint; you also have the right to go to Circuit Court and file a petition to request any of the following orders for relief:

- Restraining your attacker from abusing you;
- Directing your attacker to leave your household;
- Preventing your attacker from entering your home, school, business or workplace;
- Awarding you or the other parent custody of or parenting time with minor child(ren);
- Restraining your attacker from molesting or interfering with minor children in your custody;
- Awarding you other relief the court considers necessary to provide for your or your children's safety, including emergency monetary assistance. Such orders are enforceable in every state.
- Awarding support for minor children in your care or for your support if the other party has a legal obligation to support you or your children.
- You also have the right to sue for losses suffered as a result of the abuse, including medical and moving expenses, loss of earnings or support, and other out-of-pocket expenses for injuries sustained and damage to your property. This can be done without an attorney in the small claims department of a court if the total amount claimed is under \$10,000. Similar relief may also be available in tribal courts.

REQUESTING RESTRAINING ORDERS

If, in the last 6 months, you have been the victim of an assault (physical or sexual) by an ex or current intimate partner or by someone related to you by blood, marriage, or adoption, and who is 18 years of age, you may qualify for a restraining order.

- Orders are available at 7:30 am WEEKDAYS in the 2nd floor cafeteria, Douglas County Justice Building. BRING a photo ID. *The process sometimes takes about 2 ½ hours.*

PEACE AT HOME ADVOCACY CENTER'S ADVOCATES AND VOLUNTEERS can assist you in the restraining order process. They cannot give you legal advice and may suggest that you seek the advice of an attorney, but they will be there to help you from start to finish; from filing the restraining order to attending court, advocates are there to meet with you and go over eligibility and criteria for each restraining order available.

Stalking (ORS 163.732) A person commits the crime of stalking if: (a) The person knowingly alarms or coerces another person or a member of that person's immediate family or household by engaging in repeated and unwanted contact with the other person; (b) It is objectively reasonable for a person in the victim's situation to have been alarmed or coerced by the contact; and (c) The repeated and unwanted contact causes the victim reasonable apprehension regarding the personal safety of the victim or a member of the victim's immediate family or household.



LEGAL ADVOCACY TEAM:

Assists with Restraining Orders, Stalking Orders, Elder/Disabled Abuse Prevention Act Order & Sexual Abuse Protective Orders.

SEXUAL ASSAULT SERVICES TEAM:

provides an advocate after a sexual assault. The advocate can assist you at the hospital for a forensic examination and making a report.

Resources, Options & Safety Planning

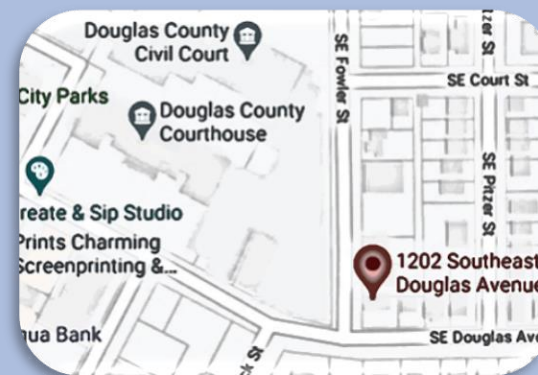
Advocates may assist you with in-person peer counseling, crisis intervention, safety planning, referrals and most importantly, just to listen.

Crime Victim's Rights & Resources

OREGON CRIME VICTIMS' RIGHTS

As a crime victim, your right to justice includes the right to a support person, a meaningful role in the criminal justice process, to be treated with dignity and respect, to fair and impartial treatment, and to reasonable protections from the offender.

Your immigration status should not affect your access to the criminal justice systems. You have the right to have a support person.

If your case involved person-to-person crime, you may be able to get financial help for counseling, medical or death-related costs.

IF THE STATE PURSUES CRIMINAL PROSECUTION, YOU HAVE THE RIGHT TO:

- **Speak** at the pre-trial release hearing.
- **Know** that orders from the court will automatically keep the defendant from contacting you.
- **Keep** your phone number and address from the defendant.
- **Request** certain conviction, criminal history and imprisonment information.
- **Request** an HIV test of the defendant if the crime involved transmission of bodily fluids.
- **Request** notice of court proceedings before they take place. You may attend open court proceedings even if you don't ask beforehand.
- **Choose** to give or refuse to give information to an attorney or private investigator working for the defendant or alleged youth defender.
- **Have** the court consider your schedule if a trial date is set.

- **Request** the district attorney consults you about a plea offer in a violent felony case.
- **Request** a transcript of open court proceedings.

IF THE ALLEGED YOUTH OFFENDER OR DEFENDANT IS CONVICTED, YOU HAVE THE RIGHT TO:

- **Be Present** at sentencing or disposition and give a victim impact statement.
- **Receive** restitution.



YOU MAY HAVE OTHER RIGHTS IF YOU ARE A CRIME VICTIM OF:

- Disabled person abuse,
 - Family abuse or elder abuse,
 - Sexual Assault,
 - Stalking, or
 - As an immigrant who is a victim of crime.
- * Some of these rights are automatic but others must be requested.*

OTHER DIRECT ASSISTANCE:

- Peace at Home Advocacy Center* can refer you to places that could meet your needs locally but does not give out funding.
- Limited assistance with gas vouchers, food boxes, hygiene items, diapers, door lock changes and emergency 911 phones is provided.
 - Emergency Shelter may be available.
