

TRANSITIONAL DIVERSION PROGRAM

Partnering Together for Societal Solutions



GOAL OF PROGRAM

Get unhoused into a position where they no longer lack resources, thus reducing lawless behavior.

PROCESS:

1. If Judge convicts Defendant for an unhoused related offense
2. Judge imposes a sentence
 - a. Jail time
 - b. Fine
3. Judge evaluates Defendant to ascertain if they are a candidate for diversion program
4. **IF** Defendant is eligible for diversion program
 - a. Judge explains defendant will have 60 days to successfully complete diversion, at which point defendant's sentence will be commuted
 - b. Defendant is directed to go to Adapt
 - i. Staff at ADAPT will conduct an assessment of what Defendant needs to better their situation
 - ii. Staff will work with Defendant to come up with reasonable achievable goals
 - iii. Defendant will have 60 days to achieve these goals
 1. Defendant will be required to check in with Staff weekly
 - iv. Following the completion due day, Staff will complete applicable form and provide it to Municipal Court, advising what Defendant accomplished and if they completed their goals.
 1. If Defendant doesn't complete their goals, Judge will impose original sentence
 - v. Roseburg Municipal Court will keep a record of defendants who go through the Diversion program
